3.	Guest Presenter owns the Presentation. University shall own the Recording, and Guest Presenter hereby assigns their entire right, title, and interest in the Recording to the University. Guest Presenter understands that University will use, reproduce, display, distribute, adapt, modify, broadcast, create derivative works and otherwise explore (via television, radio, print media, internet, webcasts, podcasts, other streaming services, original programming, or through any other communication medium existing or later created) the Recording. Guest Presenter hereby authorizes and irrevocably consents to the use of their name, likeness, and voice in the Recording for University's use. Guest Presenter hereby retains and University hereby grants a non-exclusive license to use the Recording for Guest Presenter's non-commercial purposes.		

4. Guest Presenter represents and warrants that (a) Guest Presenter has the right and authority to enter into this Agreement; (b) has the entire rights necessary to grant the licenses herein; and (c) the Presentation is the Guest Presenter's original work and will not infringe on any third party rights.

- 5. Guest Presenter agrees to indemnify and hold the University harmless from and against any and all claims, damages, liabilities, injuries, expenses or losses, including, but not limited to, reasonable attorney's fees and costs, by reason of any suit, claim, demand, judgment or cause of action initiated by any person, or an award of damages arising out of or in connection with University's use or transmission of the Recording or any breach of this Agreement by the Guest Presenter, including any claims of infringement, unless and to the extent that the claim results from the negligence or willful misconduct of the University.
- 6. The Guest Presenter is retained by University solely for the purposes and to the extent set forth in this Agreement, and the Guest Presenter's relationship to University for purposes of this Agreement shall be that of an independent contractor.
- 7. This Agreement contains the entire understanding between the parties with respect to the subject matter hereof and may not be amended except by a written agreement executed by the Parties. The Guest Presenter shall not assign any rights or obligations under this Agreement without the prior written consent of University. University may terminate this agreement with 24 hours prior notice to Guest Presenter. This Agreement may be executed in multiple counterparts.
